

Module Title: Fiqh: Ḥajj, Jihād & Amr bi-l Ma'rūf

Module Code: FIQHJA

Course Duration: 17 Weeks

Teaching Method: 2 units/week

Credits: 5

Overview:

This module will provide students with extensive knowledge of the juristic process of deriving the rulings on *Ḥajj*, *Jihād* and *Amr bi-l Ma'rūf*. The module will familiarise the students with the language and terminology employed by classical jurists in the process of derivation of laws (*al-fiqh istidlālī*). Accordingly, the students will engage in a detailed study of the laws, the juristic method of extrapolating them from the sources of Islamic law, and critical analysis of the juristic procedure and its ensuing rulings. The module aims to delineate the similarities and differences in the rulings on *Ḥajj*, *Jihād* and *Amr bi-l Ma'rūf* with the four Sunni Schools of law. Moreover, this module will also link the study of law with the study of *ḥadīth* methodology and *ḥadīth* criticism.

Syllabus:

Learning outcomes:

On completion of this module, the successful student will:

- Have acquired extensive knowledge of the rulings of *Ḥajj*, *Jihād* and *Amr bi-l Ma'rūf* in traditional Shi'i *madhhab*
- Have knowledge of how the rulings are derived from the different sources of law, and jurisprudential procedures and principles
- Understand how the principles discussed in *uṣūl al-fiqh* are applied in *fiqh*
- Show a general understanding of the main terminology used in *fiqh*
- Have awareness of the similarities and differences of the rulings regarding *Ḥajj*, *Jihād* and *Amr bi-l Ma'rūf* between the Shi'i and the four Sunni Schools of law.
- Be able to link the study of law with the study of *ḥadīth* methodology and *ḥadīth* criticism
- Be able to contextualize historical *fiqhī* debates and draw out areas of relevance to contemporary concerns
